Present at the Board meeting was, B Zidel, D. O'Neill, J. Nemnich, D. Hillard, B. Taylor, S. Fuller, D. Golde, T. Trudnowski, Guests were, Virginia Wright, J. Pickell, and Mac McCulloh, Pres. GHRHS. The meeting was called to order at 9:04. Virginia Wright, Director of the PNRA had requested to talk to the Board members about Atom, the web publishing system being developed/used at the PNRA. Development and installation is in year 6 (started 2018). Virgina's primary concern is to ramp up the installation, fix things as soon as logical. I think the completion figure of 30,000 photos loaded accounting for approximately 6% of total (500,000 at PNRA) to date. She is looking to the Historical societies for their priorities. Dean spoke for the NPRHA in that we use SharePoint and he pointed out that we, the NPRHA will be needing to move to an online version as our current version, in the future will not receive support. Atom is a good upload tool while SharePoint is good for maintaining lists. Dean also talked about tool component of Atom and the project management. In our capture of information Dean made the point of how photos are very important and draw interest, while list have their place, they are not what draw the historians. Granted lists, can get you to go look in another direction or assist in a search. Virginia talked about what are Atom's next steps such as making it fast and easy to crowd source. Determine whether to use internal or external resources. Be thoughtful about directions. Atom is a match for the Library of Congress, and how does that work with the users one would find at the PNRA. Does using it require too sophisticated a training for the average PNRA user.

NPRHA would still like to keep their SharePoint data base and example being put forward that it is easy to upload excel into SharePoint.

Virginia pointed out that figuring what to do with data; can be managed differently, provided there is a good search mechanism.

Dean offered that he and Kent would look at the current situation and bring a proposal for Atom. Develop a mission statement and evaluate where we are the progress on Atom.

Virginia briefly mentioned training and the need for flexibility and the training tools should reside on the PC.

Dean made a final statement in that the reason for associations such as the NPRHA are to be important. Important from the prospective of Historians and the first thing we must do as a association is to help historians.

The technical conversations went on for over an hour, frankly some of us maybe understanding 50% however there was break in the action. Bill Taylor interjected and stated that there had been a lot of technical talk about two systems, approaches, currently in use, one at the PNRA and the other at NPRHA. Bill offered that the parties, however they chose to meet and to bring in all necessary parties to discuss the roles of both Atom and SharePoint. Come to a consensus and come to the Board with recommendations.

Dean - The issues are not just tooling or money problems. Use of trained volunteers to populate the historical/railroad data.

Virginia in addition to the technical and knowledge aspects.

Virginia said the Bill P., Dean and her and whoever else may be required complete and acceleration plan for Atom 2.0 Provide suggestions on what the NPRHA would like to do. They would return back to the board in 90 days.
